Any special remarks/Comments: (2023-24)

- College and Hospital building are partially separated.
- Computerized central registration system is not available. Data are maintained in central register.
- IPD beds are not labelled as per norms.
- Functioning of IPD is not found up to the mark it should be improved.
- Teaching Pharmacy is next to central library which should be shifted to another appropriate place.

- 1) The Institute has to fix the Admission and other fees as per recommendation of the Committee of Retd. Hon. High Court Judge appointed by Govt. of Gujarat as per the direction of Hon'ble Supreme Court from time to time.
- 2) The admission must be made by the Central Admission Committee, State Government.
- 3) The University will carry out inspection every year at your cost.

- 4) The University has received Rs. 5,00,000/- (Rupees Five Lakh) as an affiliation fees from you for the academic year 2023-2024.
