DEMIC	Online registration system is not functional till yet which is under progress. In panchakarma and shalya department good work is going on but the nursing staff regulatory system is not satisfactory. Patient diet delivery system should be improved.	1. To comply with the guidelines of NABH and the upcoming MSR we were migrating from just the Online Patient Registration system to a more collaborative, digitized and cloud-based Hospital Management Information System by the name PRAKHAR. This software will enable us to uphold real-time information and decision-making about the various department and processes in the hospital and identify issues and bottlenecks. Since the HMIS was deployed the same day of the visitation, we were under the process of migration of data from the old system to a new one. We were therefore unable to demonstrate data in the new system. The Online Patient Registration System is now online and functioning and the same can be demonstrated now from anywhere anytime at www.appsites.in/kjiar 2. Since we are NABH certified Healthcare organization we periodically review the performance of Patient Care staff. We have a comprehensive review system for Nurses. After this comprehensive review, regular training is conducted as per NABH Guidelines. Out of which 24 (~78%) have already secured Gujarat State Registration. Balance 7 faculties are in various stages of the process. The Process of Transfer of Registration to Gujarat State involves 3 steps. 1. Application for Registration to GBAU 2. Application for Verification of Degree to the University from where the person has passed the Qualifying Exam (BAMS) 3. Securing an NOC from the previous Board for registration in GBAU All our 7 teachers who have not secured Gujarat State Registration are in various stages as follows. 1. Dr. Aparna Yadav & Dr. Hrishikesh Gaitonde have completed the 1st step & have applied to Mumbai University for degree verification, the verification will be directly sent to GBAU after which GBAU will release a note to submit the NOC from MCIM within 45 days. The payment receipts of these applications are attached as evidence. 2. Dr. Abhita A, Dr. Preeti Salvi, Dr. Archana Patil and Dr. Vishnu A have applied for registration at GBAU and will be applying for the Degree verification soon. The payment Receipts of their application to GBAU are attached as evidences.
